LPA PUBLIC HEARING MEETING MINUTES
February 24, 2015**

CALL TO ORDER

The LPA Public Hearing was called to order at 7:37 p.m. by Vice Chairman Prince, who led in the Pledge of Allegiance. The meeting was held at Town Hall located at 247 Edwards Lane, Palm Beach Shores, FL 33404.

PUBLIC HEARING

Consider and make recommendations to the Town Commission regarding the following ordinances:

ORDINANCE NO. O-2-15

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF PALM BEACH SHORES, FLORIDA, AMENDING ITS CODE OF ORDINANCES AT CHAPTER 34. FLOOD PROTECTION AND CONTROL. BY AMENDING ARTICLES I, II AND III FOR INTERNAL CONSISTENCY, CONSISTENCY WITH THE FLORIDA BUILDING CODE, AND IN CONFORMANCE WITH REQUIREMENTS OF THE NATIONAL FLOOD INSURANCE PROGRAM; AND AT CHAPTER 14. BUILDINGS AND BUILDING REGULATIONS. BY AMENDING AT ARTICLE III, SECTION 14-108, AT 107.6.1 OF THE ADMINISTRATIVE PROVISIONS OF THE FLORIDA BUILDING CODE, TO REGULATE THE ISSUANCE OF PERMITS BASED ON AFFIDAVIT, IN CONFORMANCE WITH REQUIREMENTS OF THE NATIONAL FLOOD INSURANCE PROGRAM; PROVIDING THAT EACH AND EVERY OTHER SECTION AND SUBSECTION OF CHAPTER 34. FLOOD PROTECTION AND CONTROL. AND CHAPTER 14. BUILDINGS AND BUILDING REGULATIONS. SHALL REMAIN IN FULL FORCE AND EFFECT AS PREVIOUSLY ADOPTED; PROVIDING A CONFLICTS CLAUSE A SEVERABILITY CLAUSE AND AUTHORITY TO CODIFY; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Attorney Keith Davis read the Ordinance by Title only. He stated this ordinance is for housekeeping purposes only, and that the Town must accept the changes represented in the document or we will not be in compliance with FEMA.
